PROXY VOTES AND BUDGET

Earlier this year, two board members thoroughly reviewed all the historical WPOA documents in several boxes that were inherited from the previous WPOA president. They discovered a previous (1989) by-law revision that allows a property owner unable to attend a meeting to specifically designate a proxy to vote on the homeowner's behalf using a form authorized by the board. This previously adopted revision has been incorporated into the bylaws available for download at the website (http://wpoa.us) as Article I, Sections 3 and 4. Street Lighting:

In response to concerns about safety and energy efficiency, the Wilderness Board of Directors has been investigating an upgrade to our current street lights; by transitioning to brighter and more energy efficient LED lighting.

Puget Sound Energy has indicated this would require replacement of the entire top part of the light fixture, and not just swapping out bulbs. Since there are no funds in the current budget for this work, the board has decided to stage it over several years, and use residual funds from previous year budgets to start.

With the savings from the newly installed LED lights, additional money can then be put toward new lighting. Staging of the project will take a few years to completely replace all lights. More detailed information about the lighting project will be provided at the semi-annual meeting June 8.
