REMINDERS

WPOA Pet Waste Disposal: Over the last few months, the Board has given new life to our community's pet waste dispensers. The Board is stocking the dispensers with waste bags. We ask our community to please: (1) Dispose of pet waste in waste receptacles and not to leave waste bags piled near the dispensers or in the common areas and (2) Please email the Board, WildernessBoard@gmail.com, if the dispensers are empty or damaged and please do not fill the dispensers with grocery or bread bags, which may cause damage to the dispensers.

No Burning of Garbage and Waste: A reminder to our community during this time of spring and yard clean-up, the WPOA Covenants (C-5 and B-12, see below) do not allow dumping, storage or burning of trash, garbage and other debris, including yard waste, on property lots or in WPOA community areas.

- C-5 Dumping and Storage of Rubbish and Waste: No storage, dumping or burning of trash, garbage, rubbish or other waste shall be allowed within the confines of the community areas.
- B-12 Garbage and Refuse Disposal: No lot shall be used or maintained as a dumping ground for rubbish.
 Trash, garbage and other waste shall not be kept except in sanitary containers. No garbage shall be disposed of by burning or burying.
