## **Treasurer's Report**

- The Board reviewed and approved an amended Operating Revenue & Expense report for the year 2024. The amended report includes the December bill for the Landscaping contract.
- A discussion of current accounting procedures including use of the on-line version of Quick Books, CD options, and the impact of potential management options were identified. Ben, Brooke, John, and Nick all offered input, but no final consensus was reached. It was agreed further study is needed. Property Management options will be a major factor in future decisions.

# **Election of the Secretary position**

After some discussion of the duties, Albert consented he would be willing to hold the
position for the next year. Nick moved to nominate Albert, Larry 2nd the nomination.
Albert was then unanimously elected to the position.

### **RNA** grant status

 Ben provided the Board with the status report of recent activities. The grant application is due February 20, and will address construction of a gravel pedestrian trail from Centennial Elementary School through a Wilderness greenbelt. Ben will follow up with RNA.

# **Donnelly/Wiggins Wilderness Sign**

 Nick has had discussions with representatives from Washington Middle School and others concerning the construction of a Wilderness sign for the corner of Wiggins & Donnelly. He identified several issues that will make sign construction difficult and costly. He volunteered to further pursue other options and was informed that a potential budget might be approximately \$3,000.

### **Neighborhood Welcome letter**

 Nick drafted a welcome letter intended for new residents moving into the Wilderness neighborhood. The draft was distributed to all Board members via email.
 Consensus was it provided all necessary information. Nick volunteered to distribute the letter to future residents.

### **Meeting Notification options**

 John opened the discussion of the legal requirements for notifying resident of WPOA meetings. Essentially all residents must acknowledge they received notice of meeting by signature. Several options were identified, with the financial ramifications being a major concern. No consensus was reached.

#### **Greenbelt Activities**

- Christi McGinley provided a detailed presentation with pictures, maps, and photos of recent activities by the Greenbelt volunteers. Some of the activities identified were:
  - Clearing brush and blackberry from the trail head at the intersection of Frontier & Highline
  - Coordinate future Firewise activities
  - Possible Greenbelt Newsletter
  - Proposed Installation of informational kiosk
  - Proposed future plantings & budget
  - Additional work to include removal of danger trees by the County on 46th Court
